Pursuant to agreement between Administration and Teamsters Union Local 700, Article XIV – Job Posting and Transfers, Section 14.3 – Posting of Vacancies and Bidding, I. DOC, C. Special Assignment of the Collective Bargaining Agreement and consistent with Article K – Straight Seniority Bid Transfer of the Sheriff's Employment Action Manual ("SEAM"), Transportation Unit In-House Bid will take place **Wednesday, October 24, 2018**. #### Requirements:

The Transportation Unit of the Cook County Department of Corrections requires an applicant to meet specific requirements necessary for obtaining that position. Within this posting, to bid a position within the Transportation Unit the employee must meet the following requirements, which must be produced at the time of bidding and verified prior to awarding the assignment:

1. Deputy Card (in deputized status);
2. Current and valid Firearm Owners Identification Card; and
3. Current and valid Driver's License.

#### Instructions:

1. One (1) standard bid slip will be utilized for bidding available location(s), shift(s) and day-off group(s) listed below.
2. The one-cycle Transportation Unit In-House Bid will take place on Wednesday, October 24, 2018, at the location listed above. Each employee has been assigned a bidding time in order based upon his/her verified seniority date. These times are scheduled below.
3. Bid slip(s) will not be accepted outside of each employee's scheduled date and time as listed below.
4. Bid slip(s) must be completed and include the following:
  - The date completing the bid slip;
  - Name (Last, First, MI);
  - Employee Number;
  - JDE Number;
  - Current Work Assignment;
  - Current Shift;
  - Current Detail;
  - Choice of Selected Available Location;

- Choice of Selected Available Shift;
- Choice of Selected Available Detail;
- Signature; and
- No Political Consideration Certification.

5. Any employee that fails to submit a fully completed bid slip will not be considered for the Straight Seniority Bid opportunity.

6. Effective date of each employee’s awarded bid will be: **To Be Determined**




