 - Star Number;
 - JDE Number;
 - Deputy Status;
 - Rank/Title;
 - Seniority Date;
 - Gender (for BFOQ positions);
 - FOID, including expiration date, if applicable;
 - Driver's License Number, including expiration date, if applicable;
 - Current Division or Work Assignment;
 - Present Shift;
 - Present Detail;
 - List each position being bid for: including: shift, detail and choice order for the position;
 - Signature; and
 - No Political Consideration Certification.
5. Any Correctional Lieutenant that fails to submit a fully completed bid slip(s) will not be considered for the Straight Seniority Bid opportunity.
6. Pursuant to Policy 101 Conduct, section 101.5.7 (g), no Correctional Lieutenant shall bid to a vacancy in which he/she would directly supervise any family relative or be directly supervised by any family relative.
7. Any Correctional Lieutenant that wishes to rescind a fully completed bid slip(s) must do so by reporting in person by the close of the bid, 1500 hours on Friday, September 27, 2019, to the Administrative Reports Office, Division V, First Floor, Old Superintendent's Office.


